Definition of LCD Case

- 1. Irish Turnover greater than €190 million on a Group basis or tax payments greater than €18m on a Group basis.
- 2. IDA supported companies with greater than 300 employees.

Additionally, the following special category cases/sectors regardless of size:

- 3. All financial institutions (except credit unions)
- 4. All securitization companies (Section 110 companies)
- 5. All stockbroking firms
- 6. All aircraft leasing companies
- 7. All insurance/reinsurance companies
- 8. All investment funds (including investment managers and service providers to the funds)
- 9. All REITs (Real Estate Investment Trusts)

LCD Case Base

- During 2020, ongoing reviews of the LCD case base resulted in cases moving both to and from LCD where they met or no longer met the relevant criteria. In 2020, 56 Groups moved out of LCD and 83 Groups moved into LCD. In order to create stability in the case base it is intended that from 1 April for a period of 3 years, no more substantial changes will be made.
- In addition to the above, all remote bookmaking cases were transferred in early 2021 to the Medium Enterprise Division.

Services Centralised in LCD's Customer Service Branch

- Communication management: directing written correspondence, operating the Business Taxes phone line;
- Registrations: New companies, new taxheads, VAT Groups, agent links;
- **PREM Support**: PAYE Exclusions/Dispensations, refunds for Tax Equalisation cases; transfer of employees;
- CT Customer Service: processing refunds (within thresholds), amending filing periods, support for ROS filing issues;
- VAT Customer Service: processing refunds (for CCF cases), completeness checking for VAT 56 applications;
- **CG50 Support:** completeness checking for paper applications; support for use of the online system;
- Letters of Residence: support for the online system, issue of paper letters for certain taxpayers, processing Withholding Tax Claims
- Stamp Duty processing: processing payments for Insurance Levies and Stamp Duty on Financial Cards.
