


## Fantasy Budget 2023

## The Role of Tax in Budget 2023

Every year the Minister for Finance introduces a Budget to raise revenues to provide vital services like education, health and welfare. It also aims to create jobs and to positively influence behaviours, for example by reducing harmful behaviours such as smoking. Many interested groups including the Irish Tax Institute make pre-Budget submissions in order to influence the outcome of the Budget.

There are many questions that the Minister needs to ask himself before the Budget can be finalised. Is he taxing the right areas? Should tax rates be increased/reduced? Should certain groups get special allowances and incentives? Should new business incentives be introduced to stimulate economic growth and create jobs?



## Imagine You are the Finance Minister

The economy has improved in recent years. However, the global economic outlook has rarely been more uncertain or so perplexing. Inflationary pressures have resulted in a cost of living burden which the government plans on addressing in Budget 2023. The case has also been made to increase spending in areas such as health and housing and to reduce taxes further.

Budget 2023 will be announced on 27 September 2022.

We invite you to form a team and critically analyse:

1. One key measure that impacted the individual/family;
2. One key measure that impacted indigenous Irish business; and
3. One key measure that impacted foreign investment into Ireland (1,500 words).

In addition, your team should also put forward one measure that you feel the Minister should have introduced (500 words).

Leading economists and business commentators on the judging panel will be looking for originality, sound reasoning and an awareness of the likely impact of your proposal. Marks will also be awarded for layout and presentation.



### WHY ENTER?

- Win fantastic prizes for your team and for your university or college.
- Have your ideas evaluated by some of the country's leading thinkers in the areas of tax and economics.
- Apply your knowledge of the academic theory you are studying to a real life situation.
- Use your entrepreneurial flair to come up with creative ideas for raising revenue and bolstering the economy, and improving the quality of life for the citizens of the country.
- Use the experience gained to enhance your CV.

### NEXT STEPS

1. Form teams of three or four students
2. Liaise with your college lecturer and submit your entry through him/her
3. Enter submissions as a Word document to [fantasybudget@taxinstitute.ie](mailto:fantasybudget@taxinstitute.ie)
4. Include:
  - Team name and team members names
  - Name of university/college and lecturer
  - Contact details
  - Word count
5. Submit your entry by 11 November 2022

#### POINTS TO NOTE

Note: Submissions **must not exceed 2,000 words** (including appendices). It is not necessary to supply costings, but teams may do so if they wish. The decision of the judging panel is final and the Irish Tax Institute will not enter into negotiations following the announcement of the winner.
